



On the recommendation of the committee constituted for the purpose of formulating modalities for the conduct of Unit wise examination at PG-Level the Vice-Chancellor, in anticipation of the approval of the competent authority, approved the enclosed guidelines for the new pattern of examination at PG-level. The new pattern would be effective from the session-2016-17. However, because of time lag between the commencement of class-work and closure of admissions, the system would be operative from the second semester of the session under reference except for the examinations of Generic and Open Electives which shall be held as per the new guidelines.

It may also be noted that the pattern of the question paper for the 1st semester-2016 (Core & Discipline Centric Courses) would be as shown in **Annexure-I.**

GUIDELINES FOR THE IMPLEMENTATION OF UNIT WISE EXAMINATION AT PG-LEVEL W.E.F-2016

- 1- The pattern of examination for P.G. Courses shall be as under:
 - i. There shall be three Examinations for Courses with Credit Value of 3 and above. The first two examinations shall be conducted for unit –I and Unit –II, respectively, and the third examination shall be a Term End Examination for the remaining part of the syllabus. The pattern of examinations shall be as under:
 - A. 4 Credit Course: Total marks= 100**
Examination-I – For Unit-I of the syllabus (Max. marks = 25)
Examination –II- For Unit-II of the Syllabus (Max. marks = 25)
Examination –III (Term end Examination) For Unit-III & Unit IV (Max. Marks= 50)
 - B. 3 Credit Course: Total Marks = 75**
Examination-I – For Unit-I of the syllabus (Max. marks= 25)
Examination –II- For Unit-II of the Syllabus (Max. marks= 25)
Examination –III (Term end Examination)-
For Unit-III of the syllabus (Max. marks= 25)
 - ii. There shall be two examinations for courses with Credit value 2. The first examination shall be conducted for Unit-I and the second examination (Term End Examination) for Unit-II:
 - 2 Credit Paper Total Marks = 50**
Examination-I – For Unit-I of the syllabus (Max. 25 marks)
Examination –II- (Term end Examination) For Unit-II of the Syllabus (Max. 25 marks)
- 2- For Examinations other than Term end Examinations the questions papers shall be set by the concerned teacher/s. The Evaluation of answer scripts shall also be made by them
- 3- For the Term end Examination there shall be a common question paper for all the campuses/colleges. For this examination the concerned HOD at the main campus shall procure the question papers from the concerned teachers of the main/ off-site campuses and colleges to set a synergized question paper by choosing the questions from the procured question papers without compromising the quality of the final question paper.
- 4- The HOD/Coordinators concerned shall ensure that all the themes/sub themes of each unit are completed before the examination is conducted. To this effect, as per the existing procedure, they will submit a course completion certificate before conducting the examination.
- 5- The question paper shall necessarily cover all the themes and sub-themes of the unit.
