1. Applications, to be submitted from **March 30, 2016**, are invited from the eligible candidates for admission to 3-year integrated Ph. D programme in the following faculties/disciplines:-

2. Admission to the Ph. D programme shall be made in accordance with the latest statutes issued by the University on 24-09-2014. The eligibility criteria and the procedure for applying can be accessed on the official website of the University of Kashmir (www.kashmiruniversity.net).

3. Applications shall be submitted online by accessing the official website of the University (clicking on the link for 3-year integrated Ph. D programme). The auto generated (after online submission) application form alongwith pay-in-slip for depositing the Entrance Test fee of ₹500/- in Hazratbal branch of J&K Bank in favour of the Dean Research bearing No. 0007040500000333 can then be downloaded by the candidate. The auto generated application form along with the University copy of pay-in-slip and relevant certificates shall be received in the offices of concerned Deans of the faculties upto **20-04-2016**. List of verified/screened applications (hard-copies as well as soft-copies) will be forwarded to the office of the Dean Research for conduct of Entrance Test by the Admissions Committee.
4. Date for conduct of Entrance Test will be notified separately. **Entrance Test shall comprise of 100 objective type questions to be attempted in 120 minutes.** Question papers will be set from the syllabus prescribed by concerned Department which can also be downloaded from the official website of the University.
5. Admission shall be subject to the availability of seats in the concerned Department/s.
6. Candidates having qualified (a) National level Examination like, NET/SET (CSIR, UGC), BET, DBT (Govt. of India) ICMR, ICAR, INSPIRE Fellow (DST) (b) University/College Teachers with three years service on substantive basis or with JRF and 2-years service on substantive basis, are exempted from appearing in the Entrance Test, but they are required to apply alongwith the other candidates within the stipulated time. In case the number of applicants under category (a) is equal to or more than seats available in a particular Deptt., no entrance examination will be conducted in that Deptt. and the selection will be made amongst the eligible candidates on the basis of merit with preference to JRF's.
7. Candidates whose M.Phil result has been declared or yet to be declared by the University of Kashmir are also eligible for the Ph. D programme without appearing in the Entrance Test and their Ph. D registration shall be governed by 2010 statutes. Further, the candidates with the M.Phil degrees from other UGC recognized Universities/Educational Institutions can also apply. However, they shall have to appear and qualify the Entrance Test with, atleast, 60% marks and their Ph. D programme shall be governed by 2010 statutes as well.
