# Auction of Fruit & Grass

## Terms & Conditions

- CDR of Rupees Five Thousand Only (Rs 5000/=) pledged to Registrar, University of Kashmir be attached with the bid.
- The last date for submission of bid is 11<sup>th</sup> July, 2016 upto 3PM. The minimum bid will start at Rupees Two lakhs only (Rs 2, 00,000/). The interested bidders can visit the site before 11<sup>th</sup> July, 2016.
- The successful bidder has to deposit the full bid amount at the time of issuance of formal order by the University.
- The successful bidder has to seek the permission from the University authorities at the time of cutting of grass/lifting of fruits etc.
- The successful bidder has to cut the auctioned grass before **30<sup>th</sup> July, 2016** and has to lift the auctioned fruit before **15<sup>th</sup> October, 2016**.
- The successful bidder shall have to ensure the safety of the University property during the lifting of grass/fruits and if it is reported by University watch and ward, that the concerned bidder has damaged any university property, the action under rules will be taken and the bidder will be debarred from entering in the Zakura campus and the amount deposited by the bidder will be forfeited.
- The University of Kashmir will not be responsible for the safety of the auctioned grass/fruit. The successful bidder has to himself make necessary arrangement for safety of auctioned grass/fruit.
- The successful bidder will not hamper the routine activity of the University in the Zakura Campus. The activities include field visits of students in Zakura campus, construction of new buildings, sports activities of students etc.
- Contract will be awarded to the highest bidder. However, the Auction Committee reserves the right to accept or reject any auction/bid without assigning any reason thereof.
- No conditional bid will be entertained/accepted.
- The University will not provide any transport facility to successful bidder for lifting the material.
- The bidder has to take part in full auction. Part rate or conditional rate will not be accepted.
- If the bidder fails to fulfil the terms and conditions, the amount deposited will be forfeited.
- A proper gate pass will be issued by the Estates Section/Chief Proctor Office for lifting the auctioned material, without which the bidder will not be allowed to take the auctioned material out of the Zakura campus.
- The successful bidder has to give an undertaking at the time of depositing the bid amount that he/she will abide by the terms & conditions.
