The applicant has carried two degrees simultaneously with a substantial overlap at PN 4 & 7. 3. Details provided at PN 8 invalidated. 4. The proof for teaching experience claimed at PN 11 to 13 is not attached and instead appointment order copy is been attached. 5. As per the proofs attached in the application in the form of appointment order, there is a mention of Lecturer, and the details entered in the application form shows mismatch in the position. Screening committee may decide on the same. 6. PN 14 in valid. 7. Some publications which are not in UGC care Journal e.g., PN 15-17 are invalidated. 8. Book published and mentioned at PN 35 from a local publisher. 9. Book chapters published in own book of the applicant where applicant claims points mentioned at PN 36-39, hence invalid. Screening committee may also decide on this. 10. The design of curricula or courses needs certificate at least countersigned by Dean of the faculty/Dean Academics to claim the points. Further, only few of the courses/curricula were mentioned in the certificate hence rest was invalidated. The applicant should furnish a new certificate countersigned by Dean to claim the points. 11. For PN 55 no proof attached hence invalid. 12. For projects, at PN 58 no substantial proof attached, this is an internal arrangement of the university not the finding agency. This is not individual centric extra mural grant. Since it is not a PI centric grant hence Screening committee may take call on this however, I have not deducted the score but only highlighted for Screening committee to decide on this matter. 13. For PN 59 no proof attached. 14. For PN 60 no substantial proof attached.
