2-Year LL.M Programme

On-Line Applications are invited from eligible candidates for admission to 2-Years LL.M Programme for the academic session 2024 at Main Campus, University of Kashmir. Admission to the programme shall be governed by the Admission policy available on University website and relevant statutes governing the programme.

i) Important dates:

Issuance of On-Line Application Forms	01-12-2024
Last date of submission of On-Line Application Forms and deposition of Entrance Test Fee	07-12-2024

ii) Eligibility:

Candidates should have passed L.L.B (Professional) or B.A-LL.B (5-Years) from the University of Kashmir or from any other University/Institute recognized by UGC with at least 55% marks for Open Merit and 50% marks for reserved categories.

iii) Admission Criteria:

The eligible candidates shall have to appear in the Entrance Test at their own expenses at the University specified centres for which date shall be notified separately.

iv) Submission of On-Line Application Form:

The candidates are advised to follow the below steps for filling their On-Line Application Forms.

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Enter your "**Registration No.**" and Click "**Next**".

Step-3: Enter the required details and Upload your latest passport size Photograph and click "**Next**".

Step-4: If there is any variation click on "**Previous**" button, make necessary corrections and then Click "**Submit**". Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the non-refundable "**Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test fee of Rs. 500/-**" through Online mode only.

v) Submission of downloaded Application Forms (Hard copy):

The candidates after submitting their On-Line Application Forms need not submit the hard copy of the Application Form but have to retain with themselves for future reference.

vi) Verification of documents/certificates:

- Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of submission of online Application Form. It will be the sole responsibility of the candidate to satisfy whether he/she is meeting the prescribed criterion. However, the documents will be verified at the time of Admission at concerned Department.
- The selection of the candidate will be rejected if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/suppressed the information.
